**Welcome**

Thank you for your interest in the U.S. Air Force Aerial Events Support Program. This on-line capability was developed to provide active duty Air Force, Air Force Reserve and Air National Guard operators and unit schedulers a near real-time capability to check which public events have been determined eligible by Air Force Public Affairs at the Pentagon, as well as those approved at the major command level, for potential operational support. The site also provides complete request procedures for military and non-military requestors, and is the single location to determine if a public event has been deemed eligible for support. An event eligible for support may not necessarily be supported, as flying units must carefully balance their real-world operations and training requirements with public affairs aviation event requests.




A C-17 Globemaster III banks over the Arthur J. Ravenel Bridge.

Air Force aerial support events generally fall into two categories: **Aviation/Patriotic Holiday-related** and **Non-Aviation-related**.

Requests for off-base flyovers will be considered only for aviation-related events (i.e., air shows, airport anniversaries or dedications) or for patriotic observances held in conjunction with formal observances, open to the public, on Armed Forces Day (third Saturday in May), Memorial Day (last Monday in May), Independence Day (July 4), Prisoner Of War/Missing in Action (POW/MIA) Recognition Day (third Friday in September), and Veterans Day (November 11) when held within seven days of the holiday date. This does not mean that you can request a flyover for an event on July 2nd, justifying its eligibility because it falls within seven days on one of the DoD-approved holidays. As a reminder, all sporting events require Air Force Public Affairs exception-to-policy approval regardless of the date. All other events that do not meet DoD eligibility criteria may possibly be considered as exceptions-to-policy events for one-time-only events provided there is sufficient rationale.

Aviation support that may be requested includes static display aircraft, a flyover, an aerial demonstration or a parachute team performance. An authorized flyover is a straight and level flight, limited to one pass, by no more than four military aircraft of the same general type (e.g., tactical, transport, rotary wing) from the same military Service over a predetermined point on the ground at a specific time and not involving aerobatics or demonstrations.

Aerial demonstrations are reserved for air shows only and will not be performed over other public events.

Generally, the Air Force is unable to support fundraising events. If your event raises funds for any purpose, please call the Air Force Aerial Events Office at (703) 695-9664 or (703) 695-9776, to discuss your options.

### REQUEST PROCEDURE

#### United States Department of Defense

This Web site should be used in lieu of **DD Form 2535**(Request for Military Aerial Support) to request U.S. Armed Forces aircraft participation at public events (*maximum of 3 days*) in support of community relations programs, and for requesting an aerial demonstration team (*U.S. Air Force Thunderbirds*) to perform on or off a military installation, worldwide. **Incomplete or late requests will not be considered.**

The information collected via this online form is used by the U.S. Air Force to evaluate the event for compliance with public law and Department of Defense policies, and to determine its eligibility for Armed Forces participation. Once an event has been approved as eligible, it is the event sponsor's responsibility to coordinate possible military unit participation.

The local sponsoring organization is responsible for the accurate completion of this online form and for conducting the event.

In all cases, military participation must not interfere with military operations and training programs, and must be at no additional cost to the U.S. Government. Sponsors will consult with local military recruiters and provide, at no charge, prime space at the event site for recruiting activities. Department of Defense is unable to support events for which sponsorship is intended to make a business profit. Events which have an admission charge, or other associated charges, do not necessarily preclude military participation. Military commands cannot participate in events which charge admission unless the military participation is incidental to the event, and not the primary attraction.

## TERMS & CONDITIONS

Your request for aviation support requires that you accept the following terms and conditions. If you are unable to accept these terms and conditions, your request for aviation support will be denied. Please contact us if you have any questions regarding these requirements.

**THE SPONSOR AGREES TO:** *(Items A thru H pertain to all aviation requests other than flyovers)*

- a. Obtain the air show waiver from the FAA monitor prior to the event for each activity requiring a waiver (plan a 60-day lead time). Failure to obtain a waiver will result in demonstration cancellation at the expense of the sponsor.
- b. Pay demonstration team cost as outlined on page 4, paragraph 6 or 8 of *instructions*, as applicable.
- c. Provide or reimburse transportation, meals, and quarters costs (including pre-event visits) for Armed Forces participants, as required. *(Reimbursement for demonstration teams covered in paragraphs 6 or 8 of instructions.)*
- d. Provide suitable aircraft fuel at military contract prices. *(Sponsor must pay all costs over military contract prices, including any transportation and handling charges, if fuel is not available at such prices.)*
- e. Provide security for aircraft at event site during entire stay. *(Certain assets (i.e., B-2 and F-117) will require extensive security.)*
- f. Provide mobile firefighting, crash, and ground-to-air communications equipment at the show site for flight and parachute demonstrations and static display aircraft.
- g. Provide ambulance and medical personnel on site during flight and parachute demonstrations and certain other types of aerial activities as determined, in advance, by the military services.
- h. Provide aerial photograph and airfield diagram upon request.
- i. Provide telephone facilities for necessary official communications at the event site.
- j. Provide local military recruiters, prime on-site recruiting space at no charge. At minimum the space should be 20' x 30' and it should be located on a main, high traffic area.
- k. Display Air Force messaging as they pertain to your event.

**FINAL INSTRUCTIONS**

Your request for aerial support is almost complete! To complete your submission, the following instructions apply:

1. Print (or save) the completed DD Form 2535 that appears as an Adobe Acrobat PDF file.
2. Review the request form for accuracy. If you need to make any changes, close the Acrobat window, and select the "Review/Change Form" button below. Please note that if you declined any of the terms or conditions, your request may have been modified accordingly.
3. Submit the request electronically using the "Submit Request" button below. You can make no further changes to your request after you submit it.
4. On the printed DD-2535, the agent exercising authority for site use must sign and date Section II - Blocks 3.d and 3.e.
5. The President/Chairman of the sponsoring organization (the Base or Wing Commander if it is a DoD air base) must sign and date section VII - Blocks 25.a and 25.b certifying the information contained on the DD2535 is correct and that he/she accepts the terms and conditions outlined on page three.
6. Fax the the first three pages, with all signature blocks signed, to your local FAA Flight Standards District Office (FSDO). The contact information for the office in your area can be found online at [www.faa.gov/about/office\\_org/field\\_offices/fldo/](http://www.faa.gov/about/office_org/field_offices/fldo/). The FAA will then forward the completed form to DoD. In the event the form is returned to you from the FAA, please fax it to (703) 693-9601. (Not required for static displays only.)
7. You may check the status of your request online at [www.airshows.pa.hq.af.mil](http://www.airshows.pa.hq.af.mil).
8. After you finished reviewing the DD Form 2535, you can return to the Request for Military Aerial Support Home Page by selecting Home at the top of this page. Note: Every time you select Print and Save you will receive an Email that the request has been submitted.
